1) The following is for your information and compliance. Acceptance of your application is not automatic and is subject to approval. **YOUR SIGNATURE ON THE BOURSE APPLICATION FORM INDICATES YOUR AGREEMENT TO ABIDE BY THE FOLLOWING:**

2) **Payment:** To reserve table(s) for the 2017 Silver Strike Apache Casino, this application needs to be completed, signed, and mailed with a down payment of at least \$100.00 (or payment in full) or utilize our online vendor reservation form <http://silverstrikecoinshows.com/registration/> (Make checks payable to: Silver Strike Coin Show and mail to the address shown).

Payment in full to guarantee your tables must be received no later than June 1st 2017.

3) If full payment is not received by 1st of June 2017, your table space may be re-rented and you may lose your position on the bourse floor and go to the back of the room.

4) **Bourse Tables:** 8' x 30" with 6' x 30" backups (some backups (corners/endcaps) may be smaller)

5) Table Fees: Regular 8' Table: \$100.00 Corner Tables: \$180.00

6) Only registered dealers are allowed behind their tables. Badges are limited to two per table. No table may be sub-let without prior approval.

7) Early Bird badges are \$ 20.00 and are good for the entire show, except the first two hours of dealer set-up on Friday.

8) Cancellation notices received after 15 May 2017 will be subject to a \$ 50.00 cancellation fee and resale of the bourse space. Cancellation notices received after 1 June 2017 will be subject to a charge of \$ 100.00 and resale of the bourse space. "No Show" will forfeit all payments.

9) There are a limited number of rental cases, rental is strictly on a "first come" basis. Cases may be rented for \$ 15.00, If not indicated on the application (have to rent at the show) prices will be \$ 25.00.

10) Dealers should provide their own insurance, as Silver Strike Coin Shows, cannot be held responsible for any loss or damage to material. Applicant releases Silver Strike Coin Shows, and any staff or officers thereof, from liability for any loss, theft or damage sustained as a result of this event.

11) Dealers that do not have a Oklahoma sales tax id are required to remit sales taxes to Silver Strike Coin Show at conclusion of the show. These rates are subject to change; the most current rate will be posted in your dealer package handed out at dealer registration.

12) Any person found to have material which, in Silver Strike's opinion, is counterfeit or otherwise unsuitable, will be asked to place the material in the custody of Silver Strike until after the show. Any dealer refusing to abide by these regulations or who knowingly offers to sell, or sells, unsuitable material, will be asked to leave the show (without refund) immediately. This applies to floor trading as well.

13) Other Liabilities. Exhibitor shall be fully responsible to pay any and all damages to property owned by the Apache Casino Hotel, its owners or managers, which result from any act or omission of exhibitor. Exhibitor agrees to defend, indemnify and hold harmless, the Casino, Silver Strike Coin Shows, and any of their respective owners, managers, officers or directors, agents, employees, subsidiaries and affiliates, from any damage or charges resulting from exhibitor's use of the property. Exhibitor's liability shall include all losses, costs, damages or expenses arising from, out of, or by reason of any accident or bodily injury or other occurrences to any person or persons, including the exhibitor, its agents, employees and business invitees which arise from or out of the exhibitor's occupancy and use of the exhibition premises, the Resort or any part thereof.

14) Security: There will be armed security and video surveillance on the Bourse Floor beginning at noon on June 16th. Bourse Security will continue, uninterrupted, until 3:00 PM on June 18TH. By signing this agreement the Exhibitor understands and acknowledges that any Security Personnel at the show will try to maintain order and prevent criminal acts that are visible to him/her. There can be no assurance that the Security Personnel can stop crime. Exhibitor and their agents agree to be solely responsible for any theft, damage or disappearance of their merchandise and will insure said merchandise. Exhibitor and their agents guarantee to hold harmless Silver Strike Shows, the Apache Casino Hotel and their officers, agents and representatives from any claim whatsoever resulting from their participation in this Show, including, but not limited to, theft/loss of merchandise, injury to their person, agents, assistants, spectators and/or employees, as well as disgruntled customers or fraudulent actions by others.
